ABOUT US

Resolute Forest Products is a leading producer of a diverse range of wood, pulp, tissue and paper products, which are marketed in 60 countries. The company operates some 40 facilities, as well as power generation assets, in the United States and Canada and has third-party certified 100% of its managed woodlands to internationally recognized sustainable forest management standards.

Resolute Forest Products owns two sawmills in Arkansas—the one in Glenwood and the other in El Dorado. Resolute acquired both operations in February 2020, marking the company's entry into the wood products industry in the United States. Resolute has extensive industry experience, operating nearly 20 wood products facilities in Canada.

Wood Products Operations

Glenwood sawmill produces southern yellow pine dimensional lumber as well as radius edge decking used by the construction industry in the Southcentral United States. The mill is well positioned for growth, in proximity to some of the markets with the highest population growth in the country.

Resolute acquired the El Dorado sawmill in an idled state and restarted it in December 2020. The facility, which is undergoing significant capital improvements, has 150 employees and the capacity to produce up to 147 million board feet per year of dimensional lumber and specialty products.

Supporting Sustainability

Since March 2022, Resolute's Arkansas operations have sourced wood fiber and maintained chain-of-custody and fiber sourcing certificates under the standards of the Sustainable Forestry Initiative® (SFI®), the Programme for the Endorsement of Forest Certification (PEFC) and the Forest Stewardship Council® (FSC®). Third-party certification provides the assurance that fiber-tracking systems are in place to identify the source of fiber or wood.

In 2022, the El Dorado facility provided local school districts with more than \$30,000 in funding, and the Glenwood sawmill contributed \$10,000 to the Pike County Fair and Rodeo.

Glenwood employees also achieved 250,000 hours without a single recordable injury in 2022. For every 250,000 injury-free hours, Resolute rewards employees with \$5,000 or more to donate to local organizations.
